2. Quotation Format:

- The quotation should clearly mention the unit price for each Air Conditioner, including all taxes, duties, transportation charges, installation charges, and any other incidental costs.
- GST registration number must be provided.
- PAN number of the firm must be provided.

3. Validity:

- The quoted rates shall be valid for a minimum period of 90 days from the last date of submission of quotations.

4. Warranty:

- A comprehensive warranty of a minimum of 1 year on the entire unit and 5 years on the compressor must be provided from the date of satisfactory installation.

5. Installation & Delivery:

- The successful bidder shall be responsible for the safe delivery and professional installation of all 5 units at Srinivasa Ramanujan Institute for Basic Sciences, Pampady within **Five days** from the date of receipt of the supply order.
- Installation must include all necessary fittings, piping, wiring, and commissioning.
